Section 4 - FIRST AID MEASURES

Description of necessary first aid measures

Section 5 - FIRE FIGHTING MEASURES

Section 7 - HANDLING AND STORAGE

Precautions for safe handling

Empty containers retain product residue and can be hazardous. Do not puncture or incinerate container. Use equipment rated for cylinder pressure. Close valve after each use and when empty. Protect cylinders from physical damage; do not drag, roll, slide, or drop. Use a suitable hand truck for cylinder movement.
